### NOTICE OF ENVIRONMENTAL IMPACT ASSESSMENT PROCESS

The proponent, San Miguel Fruits SA (Pty) Ltd proposes to expand citrus production at their existing operations on Portion 2 of Farm 92 Tregaron, also referred to as Sylvania, which measures approximately 243,82ha in extent. Sylvania is currently a working farm and the proponent proposes to transform an area measuring approximately 315ha, on the western section of the farm, irrigation of the proposed agricultural development requires the construction of a new dam, with a capacity of approximately 30 000m<sup>3</sup> (0.5ha footprint) and the installation of irrigation pipelines of varying diameters. Sylvania falls within the Sundays River Valley Municipal area (SRVM) and the nearest town is Kirkwood, which is located approximately 9,3km northwest of the farm.

In terms of the National Environmental Management Act, 1996 (Act No. 107 of 1996) as amended ("NEMAA") and the NEMA EIA regulations, 2014, GN R 982, 983, 984 and 985 published in Government Gazette 38282 on the 4 December 2014, the project requires full Scoping and Environmental Impact Assessment (SEIA) because it includes, amongst others, the following listed activity in GN R984 (Listing Notice 2):

"15. The clearance of an area of 20 hectares or more of indigenous vegetation..."

Other listed activities potentially triggered by the project are:

GN R985 (Listing Notice 3): Activities 2 (b) ii, (d) and (f); 4 (b) ii, (ee) and (gg); 12 (a) i.
