Full copies of the report can be downloaded from the website www.publicprocess.co.za The issues that have been raised to date by I&APs and organs of state are included in the Comments and Reponses Trail in Chapter Four of the Draft CSR and responses have been provided to the issues raised.

Input received from I&APs and organs of state forms an important part of the Scoping Process and assists in determining the scope and Terms of Reference for specialist studies as well as the assessment of alternatives, to be undertaken in the EIA Phase of the assessment.
